SOTOGRADE, SPAIN

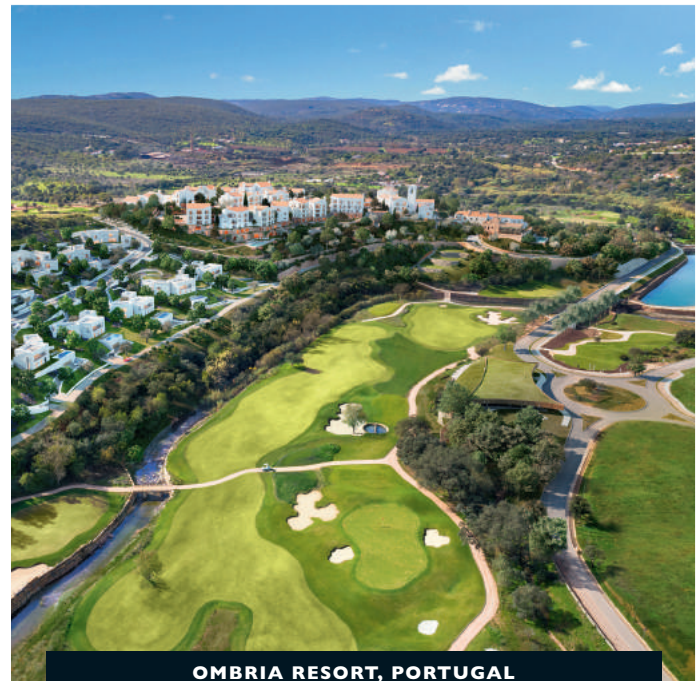
